Uncontrolled Residential Electricity is an electricity supply that has no restriction on when or how the electricity is used. Most customers with gas water heating will be on this pricing option.

Composite Residential Electricity is similar to the below controlled rate but is controlled by one meter rather than separate meter wired to appliance.

Controlled Residential Electricity means that part of the customers electrical load, normally their water heating can be controlled for a small period during peak times for appliances that are permanently wired to a separate controlled meter
